Application for Registration - Notes

<p><b>1 BREEDER</b> The Breeder is the registered owner of the Dam on the date of Birth of the kittens. If the breeder is also the owner, they do not need to complete the breeders box details.</p> <p><b>2 REGISTERED PREFIX</b> (see also note 4 below) Fill in this box only if you have a GCCFI Registered Prefix and are also the breeder of the kittens you wish to register.</p> <p><b>3 DATE OF BIRTH / AGE LIMITS</b> Applications will not normally be accepted for kittens under the age of one calendar month and over the age of one year. The Executive Committee may give permission to register cats over the age limit.</p> <p><b>4 PREFIX</b> All registrations commence with a Prefix which is a word put before the breeder(s) chosen name(s). A GCCFI Registered Prefix may be purchased by a breeder/joint breeders from the GCCFI, subject to qualification, and gives the owner(s) the exclusive use of that prefix for the progeny of any female cat registered by GCCFI and owned by the breeder/joint breeders. If no prefix has been purchased then a GCCFI Administrative Prefix, no longer than 8 letters, will be applied and this will change from time to time and will not be exclusive to any breeder.</p> <p><b>5 NAMES</b> NOTE: The TOTAL number of letters allowed, including spaces, is 30, with not less than 2 words and not more than 4 including the Prefix. Applicants need to allow for the number of letters in their own Registered Prefix, or allow 8 letters if using a GCCFI Prefix.</p> <p>The following will not be accepted as a name or part of a name:</p> <ol style="list-style-type: none"> <li>a. Names of living people.</li> <li>b. Numbers in figures or letters (John 111, Robert Fourth, Louis Quatorze, Sean a Cuig etc)</li> <li>c. Repetition of words previously registered by the same person or under the same prefix except recognised appropriate breed colour words.</li> <li>d. GCCFI Show titles (Supreme, Champion, Premier, Tara, Hibernian)</li> <li>e. Names which are primarily registered business or trade names.</li> <li>f. Cedillas, accents etc.</li> </ol>	<p><b>NOTE:</b> No cat once registered may have its name changed in any particular other than if it has been incorrectly sexed, and at the discretion of the Council whose decision is final.</p> <p><b>7 BREED NUMBER AND COLOUR</b> It is the responsibility of the breeder to ascertain, as accurately as possible, and indicate on this form overleaf the correct breed number and colour.</p> <p><b>8 ACTIVE AND NON-ACTIVE REGISTRATIONS</b> <b>Non-Active Register:</b> The GCCFI will not register the progeny of cats registered on the Non-Active Register. The breeder ONLY may apply to transfer a cat from the Non-Active to the Active Register if necessary. The Non-Active Register should be used to prevent kittens, sold as pets, being used for breeding against the advice of the breeder. <b>Active Register:</b> All other cats/kittens will be registered on the Active-Register.</p> <p><b>9 DECLARATION</b> This declaration must be signed overleaf by the owner(s). If the owner is under 18 years of age, the declaration must be signed by a parent or guardian, and the applicant's date of birth must be shown.</p> <p><b>SHOWS:</b> Pedigree cats that are entered for GCCFI Shows <b>must</b> be registered. The Registration Application must be received prior to the show closing date. If a cat is to be exhibited in the name of a new owner, application for transfer of ownership must be received prior to the show closing date. Non-receipt of application may result in disqualification. <b>NOTE:</b> Cats registered on the Reference Register may not be shown.</p> <p><b>GENERAL:</b> You will receive registration certificates with your litter registrations. <b>At the time of sale</b>, you should fill in the details of the new owner on the back of the certificate. It is a protection to the kitten that you do this. To transfer ownership, the new owner should sign the declaration and post to the address shown with the transfer fee.</p>
